Grievance Form

Instructions for Candidate

1. Fill a separate form for each question (if required).
2. Fee for grievance form is Rs. 250/- per question will be submitted in the form of Demand Draft/Postal order in favour of "**Member Secretary, RSPCB**" payable at **Jaipur**.
3. Grievances regarding question paper and answer key, if any, can be submitted to RSPCB in hard copy by hand between 10.00 AM to 05.00 PM on **1st/2nd/3rd March-2021 in requisite format along with required fee.**
4. Grievances submitted **by EMAIL and by POST will not be entertained.**
5. If formation of question and its answer as per the answer key is found correct no further action would be taken on such questions. Candidate fee for question grievance would be forfeited in such cases.
6. If it is found that formation of question is correct but another answer as compared to the answer key is correct unambiguously then answer key would be updated and published and result would be calculated based on updated answer key for all the candidates.
7. In case it is found that formation of question is correct but two or more answers are simultaneously correct, all such answers would be considered as correct then answer key would be updated and published and result would be evaluated based on updated answer key. However if the candidate has darkened two circles then he/she will be awarded negative marks, even if both the options are correct as per the revised key.
8. If formation of question is wrong and/or none of the answer is correct than this would be published and all candidates including those who have not attempted it, would get marks for it.

For grievances leading to clause (6), (7) and (8) above, the grievance fee would be reimbursed.
